The establishment of subsidiary company is considered to be an acquisition of assets of the Company. The maximum transaction size is 1.88% based on total value of consideration, which is the maximum transaction size calculated from consolidated financial statements of the Company that has been reviewed by the auditor, the certified public accountant as of June 30, 2021. Moreover, all acquisition of assets transactions occurred during 6 months prior to the date of transaction has total transaction size which is less than 15% of total assets of the Company. Therefore, the transaction is not acquisition of assets subject to disclose information.

However, the Company is obliged to report such investment to be in accordance with the Regulations of the Stock Exchange of Thailand Re: Rules, Conditions and Procedure Governing the Disclosure of Information and Other Acts of a Listed Company, as this is the case where the Company acquire investments in other companies which result them to be the subsidiaries of the Company.
